REGULATIONS

These Regulations are made by The Committee of Bentleigh Bowling Club Inc. in accordance with the provisions of Clause 34 of the Constitution of Bentleigh Bowling Club Inc. dated February 2024. In accordance with that Clause, The Committee has power to make Regulations not inconsistent with the Constitution for the efficient working of The Club, and to alter, amend, or rescind same as occasion may require.

NUMBERING OF THE REGULATIONS

The numbering of these Regulations is made as if an additional provision is added to the clause of the same number in the Constitution.

5.1 Application for Membership

- 5.1.1 As soon as practicable after the receipt of a nomination the Secretary shall post it on the Club's notice board for exhibition at least seven days immediately preceding the day of election and an interval of not less than two weeks shall elapse between the date of nomination and election.
- 5.1.2 Once posted, the person nominated shall be considered a provisional member under the specific membership category and entitled to the facilities of the Club in accordance with the Constitution, until membership nomination is finalized as per Clause 5.2.

5.2 Discretion to Accept or Reject Application

- 5.2(a)(i) The Committee shall elect members by ballot and:
 - a) three adverse votes shall exclude the applicant,
 - b) the decision of the Committee as to whether any candidate has been elected or not shall be final, and
 - c) a record shall be kept by the Secretary of the number of members of the Committee voting at any election of members of any classification.
- 5.2(b)(i) Upon a nomination being approved by the Committee, the Secretary shall, with as little delay as possible, notify the nominee in writing that they are approved for membership of the Club.

5.3 Renewal

- 5.3(a)(i) A Member's payment of the annual subscription fee shall be deemed to constitute re-apply.

28 Records and Accounts

28.7 Expenditure

- 28.7.1 The Committee may approve emergency maintenance expenditure as required.
- 28.7.2 The Committee must approve other expenditure over \$5,000.
- 28.7.3 The Committee must seek the approval of the Members for any capital expenditure over \$50,000 at a Special General Meeting which is to be called in accordance with Clause 24 of the Constitution.
- 28.7.4 The amounts of expenditure defined in Clauses 28.7.2 and 28.7.3 at the date of adoption of these amended Regulations (2025) and adjusted annually for inflation thereafter.
